## GENERAL INFORMATION

**Foam-Eater** is a proprietary silicone antifoam emulsion designed for prevention and/or suppression of foam formation in aqueous solutions. The functional properties include quick dispersibility, slight insolubility, relative stability, and spreadability in ionic solutions.

**Foam-Eater** is very aggressive in agricultural pesticide tank mixes. All emulsifiers used in this formulation are non-ionic, offering superior uniformity and compatibility.

This product cannot be used for aquatic applications.

**NOTE:** Keep out of lakes, ponds or streams. Do not contaminate water by cleaning of equipment or disposal of wastes.

### READ ENTIRE LABEL BEFORE USING

**CAUTION:** Use only as directed. Harmful if swallowed or inhaled. Avoid breathing vapors or spray mists. Liquid contact with eyes or skin can cause irritation. Avoid contact with eyes, skin, or clothing. Wash thoroughly after handling. Remove and wash contaminated clothing before reuse.

## STATEMENT OF PRACTICAL TREATMENT

**If swallowed:** Get immediate medical attention. Do not induce vomiting except by physician's order. If vomiting is inevitable, prevent aspiration by keeping victim's head below the knees. Never induce vomiting or give anything by mouth to an unconscious person.

**If in Eyes:** Immediately flush eyes with plenty of water for at least fifteen minutes, holding eyelids apart to ensure flushing of the entire eye surface. Seek medical attention if irritation persists.

**If on Skin:** Remove contaminated clothing and wash with large amounts of soap and water. If irritation develops, contact a physician.

**NOTE:** If contact is made with the spray solution containing pesticides, follow the "Statement of Practical Treatment" on the pesticide label.

Store in a cool dry place. Keep from freezing. Do not reuse empty container. Dispose of container in a safe manner in accordance with federal, state and local regulations.

## DIRECTIONS FOR USE

Add **Foam-Eater** to spray liquid before foam starts to appear. This gives best foam control. If foam has already started to build, add **Foam-Eater** directly to the foam. The use of 1 to 4 ounces of **Foam-Eater** per 100 gallons of spray mixture is generally sufficient to suppress or eliminate foam from most conventional spray tanks. Agitation will aid dispersion.
