Voladex™, is a multifunctional adjuvant used to help control the volatility and drift that may occur with the use of certain forms of dicamba. **Voladex™** helps to form consistent droplet sizes within the optimum range for uniform control and accurate delivery of the application. **Voladex™** is recommended for use on all agricultural crops and is compatible with most active ingredients such as glyphosate, 2,4-D, and dicamba. **Voladex™** has been approved for use as a DRA and VRA with Xtendimax®, Engenia®, and Tavium®. Caution should be used when applying this or any other product on crops during hot, dry field conditions,

Voladex™ DOES NOT CONTAIN AMS.

Voladex™ should be used at a concentration of 1.5% v/v or 1.5 gallons per 100 gallons of solution. Always follow dicamba product label requirements.

Water Carrier Rate (Gallons of Water per Acre)	Voladex Use Rate (Fluid Ounces per Acre)
15 GPA	28 fl oz/A
20 GPA	38 fl oz/A
25 GPA	48 fl oz/A

MIXING (ORDER OF ADDITION)

Prior to mixing, fill the spray tank with half the required amount of carrier. Start the sprayer and check operation of all valves and gauges and that there is adequate tank agitation.

To prevent or minimize foaming, add an approved antifoaming agent such as **Foam-Eater**.

Add the required amount of **Voladex™**, then:

- Wettable Powders (WP) then Flowables (F, DF)
- Liquid and Soluble Products
- Emulsifiable Concentrates (EC)
- Continue filling tank maintaining minimal agitation.

Best results are obtained if spray mix is used within 24 hours of mixing.
