ADVANCE is a plant growth enhancer that contains a blend of highly-refined nutrients and natural carboxylic acids that enhance solubilization and uptake of plant nutrients. **ADVANCE** can be used in a variety of applications as a soil application to aid early season plant development

DIRECTIONS FOR USE

For in-furrow, banded, side-dressed and broadcast applications through conventional equipment use **ADVANCE** at rates derived from the table below.

CROP	RATE	
Cotton	Apply 1 - 2 quarts per acre as an in-furrow application or in a band over the row.	
Peanuts	Apply 1 - 2 quarts per acre as an in-furrow application or in a band over the row.	
Corn	Apply 1 - 2 quarts per acre as an in-furrow application or mixed with starter fertilizer.	
Tobacco	Apply 1 - 3 quarts per acre in tobacco transplant water solution.	
Small Grain	Apply 1 - 3 quarts per acre.	

With the use of this product, best results are obtained when **ADVANCE** is incorporated, injected or applied alone in a narrow band as close as possible to the germination and rooting zone of the crop (minimum depth 2 - 4 inches). The recommendations for the use of this product are based upon the best current information available.

Applications of **ADVANCE** with pesticides are possible provided that good agitation of the spray mix is maintained. Always check compatibility prior to large scale mixing and apply the spray mix as soon as possible. Follow the mixing sequences below:

- 3. Pesticides

- 4. Co-Mix
- 5. Pesticides
