#### **GENERAL INFORMATION**

**NutriSol Boron UN** is a formulation for use in soil and foliar applications on crops requiring Boron. **NutriSol Boron UN** contains Urea based Nitrogen and can be used in liquid fertilizers, suspensions or in water and is compatible with most pesticides and fertilizers. Boron primarily regulates carbohydrate metabolism in plants. It is an essential element for protein synthesis, seed and cell wall formation, germination of pollen grains and growth of pollen tubes. Boron also aids in sugar translocation.

**WARNING** - Boron can be detrimental to growing crops when over applied. Apply **NutriSol Boron UN** only when soil or tissue tests require an application of Boron. Use only at recommended rates. Use of excessive amounts or on crops not recommended may result in serious injury to and/or loss of those crops.

#### PRECAUTIONARY STATEMENTS / HAZARDS TO HUMANS

#### CAUTION: KEEP OUT OF REACH OF CHILDREN.

When used in conjunction with pesticides, consult pesticide manufacturer's label for worker protection recommendations. Use of waterproof gloves and protective eyewear is recommended when handling this product.

#### STORAGE AND DISPOSAL

**NutriSol Boron UN** is corrosive to mild steel, aluminum and brass. Store in polypropylene, fiberglass or stainless steel containers. Do not store near heat or open flame. Store in original container only. Keep container tightly closed and do not allow water to be introduced into the contents of this container. Keep from freezing. If damaged or leaking, soak up with absorbent material and place in suitable container for disposal. Transfer remaining product to suitable container for storage and label. Do not contaminate water, food or feed by storage of disposal. Do not contaminate water by runoff from equipment wash waters or spray materials. Wastes resulting from this product may be disposed of on site or at an approved waste disposal facility.

**Container Disposal**: Triple rinse (or equivalent) and add reinsert to spray tank, then offer for recycling or puncture and dispose of in a sanitary landfill or by incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.

#### **DIRECTIONS FOR USE**

This product is compatible with most pesticides and fertilizers. However, a test for compatibility is recommended prior to large scale mixing. Always add **NutriSol Boron UN** to water prior to large scale mixing. Do not apply in aqua ammonia.

#### **SOIL APPLICATION**

**NutriSol Boron UN** can be soil applied but should be incorporated. Apply 2-4 quarts per acre as a sidedress or preplant application. Crops with severe deficiencies may require supplemental soil applications of **NutriSol Boron UN** to maintain a concentration of 1 to 5 ppm in the soil. For best results when soil applied, split applications should be utilized. Do not place in direct contact with seed or starter fertilizer. **NutriSol Boron UN** can be applied alone or in combination with agricultural chemicals and liquid fertilizers.

#### **FOLIAR APPLICATIONS**

**NutriSol Boron UN** can be foliarly applied. Apply 2-4 quarts per acre by ground or air in enough water to provide maximum coverage. A nonionic surfactant can be utilized to enhance coverage and translocation. For crops requiring multiple Boron applications above 4 quarts per acre, allow 14 to 21 days between applications. For foliar applications, **NutriSol Boron UN** can be applied alone or in tank mixes with agricultural chemicals and fertilizers. The use of tissue tests is highly recommended to monitor levels of boron in the crop. Tissue tests will serve as an aid to establish and maintain correct levels if Boron for optimum plant growth and it will help in avoiding over application that can be detrimental to the crop.

**With Agricultural Chemicals:** Follow pesticide label for mixing instructions with liquid fertilizers. A compatibility test is recommended. Then:

- Agricultural Chemicals
- Agitate

#### With Fertilizers:

- 1/3 Liquid Fertilizer
- NutriSol Boron UN
- Balance of Fertilizer
- Agitate
